Before Me, the undersigned authority personally appeared SMITH A 0306 who being duly sworn, alleges, on information and belief, that on the 9 day of APRIL, 2019, in LAKE County, Florida, the defendant did:

DID COMMIT THE OFFENSE OF THEFT OF MISLAID PROPERTY AND GRAND THEFT IN THE CITY OF MOUNT DORA, FLORIDA IN LAKE COUNTY:

On April 9th, 2019, at approximately 1130 hours, Officer Krueger responded to the lobby of The Mount Dora Police Department located at 1300 N. Donnelly Street in reference to a lost wallet.

She made contact with the complainant, Michael Wynn. Wynn indicated on April 7th, 2019, he purchased an item from Lil' Sammy's Food Mart located at 446 North Highland Street in Mount Dora. Wynn advised he exited the store and was traveling down the road before noticing his wallet was missing. The last time the wallet was seen was at Lil' Sammy's Food Mart between 1600-1700 hours.

Wynn returned to the business, and asked if a wallet was turned in. An employee advised nothing had been turned in but insisted to have Wynn file a police report. The employee added if a police report was completed, a review of video footage could be viewed in attempt to see who picked up the wallet.

The wallet was black and made out of leather. The wallet contained his Florida driver license, his social security card, and \$2,000 in cash. Upon receiving a copy of the video footage, it clearly show a white male pickup the wallet, put it in his front pocket, and enter the store.

An attempt to identify the suspect, a flyer was made and distributed to all Mount Dora Police Patrol. After not getting any results from the patrol division, I had the Public information Officer put the flyer on social media. (Facebook). Someone called in and advised that the person in the flyer looked like a male known to them as Christopher David Snell. (D.O.B. 04/02/1975) with a local address listed in Mount Dora.

I was later contacted by Shawn Ushko, she advised that the person I was attempting to contact, was an employee of her roofing company. She advised that she would have Christopher Snell meet us at Lil Sammys in an attempt to exclude Snell. Upon arrival, I met with Snell, and Ushko as well as the employee that was on duty the day of the incident. The employee stated that the person in the video was Snell, and Ushko asked to see the video.
